AMENDING SECTION 2.303(1)(j) ADMINISTRATOR, FUNCTIONS AND
DUTIES OF THE MUNICIPAL CODE FOR THE VILLAGE OF WESTON,
MARATHON COUNTY, WISCONSIN

The Village Board of the Village of Weston, Marathon County, Wisconsin, do ordain as follows:

SECTION 1: Sec. 2.303(1)(j). Administrator, Functions and Duties of the Village of Weston Municipal Code is hereby amended as follows:

- j. The Administrator shall be the head of emergency management services for the Village of Weston per Wis. Stat. § 323.14(1)(b)(2). ~~and therefore, under 2013 Wisconsin Act 20 the Administrator must also reside within 15 miles of the village's jurisdictional boundaries.~~

SECTION 2: SEVERABILITY. If any section, clause, provision, or portion of this Ordinance is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder of this Ordinance shall not be affected thereby.

SECTION 3: SECTION 4: EFFECTIVE DATE. This ordinance shall take effect upon approval and publication.


