- **MAIL:** Please use the enclosed envelope to mail in your tax payment. A receipt will be mailed back for all payments received!
- **VILLAGE HALL:** Come to the Village Hall during regular business hours (**CASH OR CHECK ONLY**).
- **BANK/CREDIT UNION:** Drop off payment at any participating Financial Institutions shown below.
- **CREDIT/DEBIT CARD:** Pay by phone or online (*a convenience fee of 3% will be charged - details below*).

Please take the BOTTOM PERFORATED STUB of your tax bill to the institutions when making a payment. They will KEEP the stub for processing. The Village will mail you a receipt. Escrow checks OVER the tax bill amount will NOT be processed, please mail the check to the Village, a refund check will be mailed back.

PAYMENT DUE DATES

- First Installment: Friday, January 31, 2020
- Second Installment: Friday, July 31, 2020 (*can ONLY be paid at Marathon County Courthouse - 500 Forest Street; Wausau*)

Payments received or postmarked on or before Tuesday, December 31, 2019 will be receipted **in 2019**. Please make sure we received your payment with a postmark of 12/31/19 or before if you would like your receipt dated 2019 for income tax purposes.

LOTTERY CREDIT REMINDER

If you were occupying your primary residence as of January 1, 2019, you are entitled to a **Lottery Credit of \$198.27** on your December 2019 tax bill. If it has been omitted, please bring your tax bill with payment to the Weston Municipal Center for adjustment. If you moved into your residence during 2019, you are not entitled to a Lottery Credit until your December 2020 tax bill.

FIRST DOLLAR CREDIT REMINDER

This **tax credit of \$71.46** will appear on the December 2019 tax bill. This tax credit will appear on a line immediately above the Lottery Credit line. All taxable parcels with improvements are eligible for this credit.

2020 PET LICENSING


PetData will be sending the 2020 pet license renewal notices

The combined assessed tax rate will **increase by \$1.16** for the December 2019 tax bill. The \$23.13 tax rate is a 5.28% increase from last year's rate of \$21.97. The D.C. Everest (DCE) School District "net" tax rate will increase by 68-cents, which is a 7.60% increase from last year, and represents 41.63% of your tax bill this year. The Village of Weston tax rate will increase to \$6.89, which is an increase of 21-cents this year (or a 3.10% increase). Marathon County has increased taxes this year 18-cents and NTC increased by 9-cents this year.

STEP 1

Search by address and then click the parcel number.

(note: Enter street name with no direction and no suffix (i.e. St, Ave, Rd).

STEP 2

Under *Select Detail*, choose *Taxes*.

STEP 3

From here, you will be able to print both tax bills and receipts.
