### PAYMENT DUE DATES

- 1<sup>ST</sup> installment or full payment: Saturday January 31, 2026, at the Village Municipal Center.
- ANY payments made after January 31<sup>st</sup> WILL NEED to go to Marathon County - 500 Forest Street, Wausau, WI 54403.

Payments received or postmarked on or before Wednesday, December 31<sup>st</sup>, will be receipted in 2025.

### LOTTERY CREDIT REMINDER

If you occupied your primary residence as of January 1, 2025, you are entitled to a Lottery Credit of \$158.47 on your December 2025 Tax Bill.


Please contact us if you are entitled to this credit and do not see it. There is a form that you will need to fill out to receive this credit.

### FIRST DOLLAR CREDIT REMINDER

This tax credit of \$52.82 will appear on your tax bill. All taxable parcels with improvements are eligible for this credit.
