- Drop off payment at any participating Financial Institution. Take the STUB of your tax bill to the institutions when making a payment. They will KEEP the stub for processing. The Village will mail you a receipt.

PAYMENT DUE DATES:

- First Installment Due Date: Monday, January 31, 2022
- **Payment AFTER January 31, 2022 can only be taken at Marathon County**
- Second Installment Due Date: Sunday, July 31, 2022

Payments received or postmarked on or before Friday, December 31, 2021 will be receipted **in 2021**. Please make sure that we receive your payment with a postmark of 12/31/21 or before if you would like your receipt dated 2021 for income tax purposes.

LOTTERY CREDIT REMINDER: If you were occupying your primary residence as of January 1, 2021, you are entitled to a **Lottery Credit of \$249.52** on your December 2021 tax bill. If it has been omitted, please call the Weston Municipal Center, we will need a form filled out prior to an adjustment. If you moved into your residence during 2021, you are not entitled to a Lottery Credit until your December 2022 tax bill.

FIRST DOLLAR CREDIT REMINDER: This **tax credit of \$70.35** will appear on the December 2021 tax bill. This tax credit will appear on a line immediately above the Lottery Credit line. All taxable parcels with improvements are eligible for this credit.

2022 PET LICENSING INFORMATION:

DECEMBER 2021 TAX BILL: The combined assessed tax rate will **increase by \$.57** for the December 2021 tax bill. The \$24.13 tax rate is a 2.42% increase from last year’s rate of \$23.56. The D.C. Everest (DCE) School District “net” tax rate will increase by 6-cents, the Village of Weston tax rate will increase 29- cents, Marathon County’s rate will increase 23-cents and NTC will *decrease* by 01-cent this year.
